**Fees/Payment Information:** A \$100 Registration Fee is due along with a security deposit which is 50% of the total summer tuition. **The registration fee is NON-REFUNDABLE and not applied to tuition.** If you withdraw prior to the start of the summer camp program, the security fees will be returned until June 1, 2016. No exceptions will be made after June 1, 2016. If withdrawing during the summer camp program, the security deposit will not be refunded. There will be no change of fees due to absences, late arrival, late registration, camp closure, withdrawal or dismissal. Please adhere to the scheduled days per program. Schedules can be adjusted if space is still available. Emergency Day rates are set aside for emergency purposes by students registered in a program. The Eight Week program is discounted at 5%. The balance of the summer camp must be paid in full by June 1, 2016. A 3% late fee will be assessed on all balances after June 1, 2016. Trip fees are not included in the tuition. There is a three week minimum to register for the weekly prices. There are no extended day hours on the last day of camp.
